#### **RE: Royal Brighton Financial Results – June 2022**

Below is a summary of the Club's financial results for June 2022, as well as accompanying commentary.

#### Financial Results June 2022:

The financial reports for the period have been prepared on a calendar month basis from 1<sup>st</sup> June to 30<sup>th</sup> June 2022. The Club traded as usual throughout the month, trading for all 30 days.

The June financials showed that the Club outperformed projected Revenue results by \$118k when compared to budgeted figures. On a month-to-month basis, however, June was a slow trade month, with total Revenue reported for the period falling by \$71k. The \$60k decrease in Catering Revenue, the \$10k decline in Sailing Income, and the \$1k decline in Membership Income are responsible for the Revenue's considerable decline. Additionally, a \$5k increase in Revenue was reported in Marina, Hardstand and Storage Income. The Club earned \$440k in Revenue overall for June.

Expenses for the period have exceeded forecasted results by \$33k, though this is expected with the respective budgeted Revenue figure. Expenditure month-on-month, however, has decreased by \$30k. The substantial decrease in Expenses can be primarily attributed to the \$32k reduction in Employment Expenses. Additionally, an increase of \$12k was reported for Repairs, Servicing and Maintenance, due to outstanding invoices from previous periods recognised in June. General Operating Expenses also increased by \$3k, while other Expense categories declined month-on-month. In total, Expenses for the period came in at \$273k.

In correlation with the decrease in Employment Expenses, the Employment cost ratio has decreased slightly to 40%; it remains below the budgeted Employment cost ratio of 45%, which is an excellent result.

The Club's cash balance for the month has increased \$420k from the previous period. The decrease in Debtors and Liabilities mainly drives the significant increase in cash flow for June.

As a whole, the Club made \$82k in Operating Profit in June, which is \$47k more than anticipated, and a reduction of \$30k month-on-month. The Club's Operating Profit for FY22 exceeded projections overall by 61%, totalling \$1m at the end of the fiscal year.

June being the last month of the financial year, OTH has completed the year-end payroll reconciliation and lodgement of the final STP with the ATO has been actioned. OTH has advised management that the Club's employees can now access their income statement via their myGov accounts.

#### **RBYC Financial Results June 2022**

In June 2022, the Club recorded a net operating surplus of \$82k, \$47k above budget, and a net deficit of \$5k compared to a budgeted deficit of \$63k. Although catering revenue was above budget, monthly turnover has fallen in each month since March and was down 30% on the levels recorded in May. In contrast, over the same period, membership and marina income have been on an upward trend while sailing revenue has fallen. Overall, the gross profit was just over \$80K above budget. Total expenses were \$34k higher than budget primarily due to employment expenses exceeding budget by a similar amount and the total employment cost to income ratio was largely unchanged at 40% compared with 37% in April and March respectively. The full year results show a net surplus \$6k, which is \$526k better than projected. Some of the full year "highlights" were a \$494k shortfall in catering revenue relative to budget, marina income was 9% higher, there was a significant contribution of Government support recorded in other income and expenses were \$367k below budget. The latter reflects significantly lower employment costs and change in the accounting treatment of rent that saw it recorded in depreciation and amortisation rather than under occupancy costs. A breakdown of the net deficit across the major club functions sees catering contributing +\$104k, marina and hardstand +\$589k, while sailing and membership reported "deficits" of \$30k and \$656k respectively. The cash balance at the end of May was \$1.4m and as at the 22<sup>nd</sup> July it had risen to \$1.9m. The cash position of the Club remains healthy but any number of headwinds could derail the financial position of the Club, including rising costs and wages, a fall in consumer confidence and discretionary income, the additional employment costs associated with the continued emergence of new strains of COVID and not forgetting the significant capital expenditure and dredging requirements. Overall, a solid result for the year however we cannot afford rest on our laurels.


