Main Features

- Despite the disruptions from COVID, it is pleasing to see the Club record a strong operating performance, reduced debt, significant increase in repairs and maintenance and increased cash holdings.
- The year was one of two halves, with significant improvement in the second half of the year.
- The Operating Surplus for the year was \$1,077,235, while the Net Deficit after depreciation, amortisation and net interest paid was \$4,830.

Challenges

- Rising costs and wages and pressures on discretionary income
- Increasing marina occupancy and improving utilisation of other assets are key pillars towards improving financial outcomes
- Capital commitments going forward including dredging and marina
- Managing the seabed lease and marina pen contract renewals
- The uncertainty surrounding the course of COVID

Conclusion

- Our Club, due to the support of members, employees and Government assistance has managed to return to a more normal operating mode
- Adapting to this "living with COVID" environment, in particular for sailing, hospitality and the gym, and improving asset utilisation are crucially important to enable the Club to continue to generate future surpluses that are necessary if the Club is to continually develop services for members and undertake the necessary maintenance and capital expenditure
- There remain significant headwinds including rising costs and wages, economic uncertainty and the omnipresent threat from COVID
- Thank you to the General Committee, Finance Sub-Committee, our accountants and auditors for their support and guidance.

Niesje Hees addressed the members outlining some of her priorities for the forthcoming year, with key points being;

- Thanks to the outgoing committee, General Manager and Staff
- Acknowledgement that the club is on a firm foundation, and the importance of further progressing our Strategic Plan
- The intention to celebrate our upcoming 150th anniversary
- Reinforcing our key purpose of sailing, yacht racing, and volunteering (just getting out on the water), while understanding there are many ways to enjoy our waterfront location
- The importance of fostering a vibrant and inclusive club with strong links to the community

Simon Tedstone expressed his concern for the club and addressed these to the incoming committee. He thanked the outgoing committee for their service and noted that the General Committee were well represented on the sub-committees. His concerns include the level of participation at all levels of racing including Cruising and OTB. Niesje Hees responded that his points were well made, and that the committee will be working hard to increase the participation at all levels of sailing.

Gabriela Ammendola expressed that we do more to attract the 30 to 40 year age group, including improved social media advertising.

RBYC HALF YEARLY GENERAL MEETING – COMMODORE’S REPORT

Over the past six months the General Committee, subcommittees and staff have worked to progress initiatives in all areas of the RBYC Strategic Plan.

Sailing Pathways

It has been a rich and varied sailing season with active fleets across One Design, OTB and keelboats. The Club Captain’s Sailing Sub-committee report highlights successes in ocean racing, windward leeward, and “around the sticks racing”, as well as training programs for all ages. The Cruising Group has run several successful events on and off the water. Some sailboat and power boat owners choose to sail or cruise in isolation while others cruise in company, using the club as a destination after a day on the water. Several members have enjoyed using their boats through support of the “Sailing Lifts your Spirits” program, a wonderful initiative that rewards our skippers and crews as much as their guests, the healthcare workers who look after us. We look forward to the rest of the sailing season, including the popular BLISS regatta.

It is true that there are several boats languishing in the marina, and it would be terrific to see their owners out on the water and making greater use of their club. Our upcoming keelboat program is intended to train crew. We are hopeful this will assist skippers and crew to enjoy the benefits of sailing on our beautiful bay. People’s priorities change, and we will continue to listen to our members and keep in touch with their preferences, while promoting the programs and events we have in place.

The opportunity to partner with other clubs is explored on an ongoing basis. Through the monthly Club Captains and Commodores meetings chaired by Australian Sailing we share experiences and build opportunities for joint initiatives. It is in all our interests to pool our resources to promote the joys of sailing in an environment of competing leisure activities.

Membership

Membership continues to grow in all categories, as can be seen in the Membership report. Over the next six months we will be focused on converting members to active sailing crew and aiming to increase our crew membership numbers.

At the same time, we have come to celebrate our non-sailing membership categories. The Iceberger report provides a good sense of the comraderie and vibrancy of that group. It’s wonderful that sailors and swimmers have become better acquainted, which can only be good for the club as a whole.

The Social subcommittee has done an excellent job of running events that appeal to all members. The subcommittee report provides a summary of events that have been enjoyed over the past six months, and many of these will become a regular feature of the club’s calendar. The club’s 150th anniversary will provide a great opportunity for club members to celebrate.

Marina, Beach and Hardstand

We are conscious of our responsibility in managing the major assets which are the cornerstone of our club. Maintaining excellent and mutually beneficial relationships with government bodies and community organisations is essential to retaining our fortunate position as a premier yacht club in an enviable location. We are aware of our role within the broader harbour precinct, and the importance of having a seat at the table in discussions with other clubs and authorities.

Considerable progress was made last year in renewal of our seabed lease. This then stalled for six months due to limited resources and staff turnover at Parks Victoria. Negotiations have recommenced, as mentioned in the Assets report. While our lease expires in April 2023, we are fortunate that the delay has no immediate consequences for us. The new lease must be resolved well before any major infrastructure work progresses, including the eventual replacement of the wave attenuator. Our objective is to have the lease renegotiated during 2023.

RBYC HALF YEARLY GENERAL MEETING – COMMODORE’S REPORT

A priority for the club is dredging inside the marina. We have been told our current permit does not cover this and are in the process of ensuring the correct permit is put in place, as well as assessing proposals from dredging contractors.

I’d like to thank the members of the Assets subcommittee and the Marina and Attenuator advisory group for their expert advice on all matters associated with the marina and hardstand, including maintenance, medium term projects and longer-term strategy.

It is essential that current and future committees continue to put funds aside for the costly replacement of the attenuator, whether that be with a breakwater extension or other type of wave barrier, as well as the potential expansion or redesign of the marina.

An important ongoing consideration is our responsibility with respect to sustainable sailing. The Cleaner Sailing subcommittee has reported on initiatives under its remit, and all areas of the club must head the guidance of sporting bodies and agencies in this respect.

Clubhouse

Clubhouse projects need to consider the benefits to members as well as the marketability of our function spaces. The replacement of carpet is a big improvement, but it is recognized that ongoing cleaning and maintenance is essential to ensure the clubhouse is worthy of a premier club. Over the next six months there will be an increased focus on improvements in the regular maintenance schedule, which has been hampered by a shortage of skilled resources and contractors.

The Assets report mentions the planning work associated with the circular driveway, which is tentatively planned for the winter of 2024. This will be a beneficial addition to our club.

Catering and Functions

The Club restaurant is a popular link to the community as well as a benefit to members. As explained in the finance report, the turnover for the restaurant and for functions has improved but costs have increased. Cost containment is a priority, while at the same time finding ways of attracting a larger number of members, of both our club and the community, to our facilities. Feedback lets us know we have a terrific location and warm atmosphere, and we are keen to leverage this more successfully. I am confident the effort is worthwhile. Our friendly staff are appreciated by members and visitors, and we are keen to foster a caring club culture as well as a sustainable business.

Community

Strong community links are essential for us. We aspire to be a welcoming and inclusive part of the neighborhood. Many who have lived in the local area for decades have recently joined the club, not realizing previously that this was possible.

The Inclusion and Diversity advisory group is exploring ways to attract new members to the club from a variety of backgrounds. At the same time we need to be good neighbours, and are keen to support local initiatives. The Australia Day swim and Rotary recycle regatta are examples of ways we can help support worthwhile events.

Shared Values

Our unifying strategic pillar asks us to be respectful of each other. As a growing and increasingly diverse club we become richer and stronger. Through appreciating the experience and backgrounds of others, we will benefit personally and prosper as a vibrant club.

Lastly, I congratulate the first three RBYC women members who are being given their 40 year membership medallions at this half yearly meeting. This is a major milestone to celebrate.

FINANCE REPORT to MEMBERS

For the 6 months ended

31 December 2022

Dear Members

I present the Financial Report to Members for the six months ending 31 December 2022.

Financial Performance

The financial performance of the Club for the 6 months ended 31 December 2022 is laid out in the following pages. The Club shows a net operating surplus of \$279k and a deficit of \$257k. A comparison with last year is less meaningful due to COVID enforced shutdowns and support provided by the government. The corresponding period last year showed a net operating surplus of \$493K and a net deficit of \$60k.

The Club's Revenue is above budget by \$122K. The Club recorded a 23% increase in gross profit. All areas of the club recorded improved revenue. Marina occupancy has improved, catering revenue has returned to pre COVID levels, membership is significantly up and with no COVID lock downs there has been greater participation in sailing & OTB training programs.

In the six months to December 2022, total expenses were \$1,901k compared with \$1,276, for the corresponding period in 2021. Operating expenses were generally similar to last year with the exception of employment costs and repairs and maintenance. Despite the efforts to improve labor utilization and cost control, the rise in employment costs is due to the need to employ agency staff to fill the gaps in the operations of the catering department. Monthly total employment costs as a percentage of total income averaged 43% during the half year ended December 2022. For the previous six months the average was 44%.

The half yearly Surplus/(Deficit) of (\$257K) was significantly higher than last year's deficit of \$60k due to full operation without government subsidies. Expenditure planned for the next six months includes the installation of the new gate to the hard stand and dredging inside the marina. To take advantage of higher interest rates, a substantial cash amount has been invested in short term investments.

Catering

Improved conditions have seen the catering revenue double from last year's result, returning to pre COVID levels. This improvement has been offset by the increased cost of goods and higher labour costs, driven by a frequent need to use agency staff for key positions.

Club management have seen improved labour market conditions, resulting in a reduction in contract labour throughout the year. As these conditions continue to improve the catering profit margin will correspondingly improve. A core focus of club management is to improve the profit margin of the catering and function division.

The table below shows that the gross profit margin for the bar and catering operations has improved to 10% compared with -20%, for the same period last year. Again, last year's result was impacted by COVID shutdowns.

Marina & Hardstand, Membership and Sailing

There was an improvement in the marina occupancy, and this is reflected in a \$47k increase in the income in the six months to December 2022 when compared to the previous corresponding period. Marina occupancy during the half year, averaged 78% (last year 75%) and of the 26 vacancies, 25 were club owned pens. Hardstand utilisation averaged 99 percent. This is the same as last year. OTB storage is full. Every endeavour is being made to fill all pens. Marina revenue for the next 6 months will be strong due to the return of all pens to club ownership and higher occupancy rate.

Membership continues to grow. At the end of December 2022, the Club had 1624 members compared to the previous period in 2021 of 1526. Full details of all the categories can be found in the membership report.

Sailing & OTB income has increased by \$23k for the six-month period. This is due to popularity of the sailing programs especially the adult learn to sail programs.

Cash flows

During the six months ended December 2022 the cash balance increased by \$436k.

Conclusion

The last six months have seen increased activity at the club. The main challenges have been escalating costs and availability of skilled labour. Over the next six months, it will be important to contain costs while ensuring essential maintenance is completed and approved projects move ahead.

The Club has a healthy bank balance and has taken out some short-term investments. The improved cash position allows the Club to invest in our assets. Short term capital projects include:

- Installation of the new gate to the hard stand
- Marina dredging planned for later this year
- Progressing the circular driveway
- Planned replacement of race management vessels

At the same time, it will be important to set aside funds for the eventual replacement of the wave attenuator.

I would also like to thank the clubs Finance Committee consisting of Commodore, Vice Commodore, Club Captain and Keith Badger.

RBYC Membership

Half Yearly Report – March 2023

The General Committee emphasizes that membership is a core pillar of our strategy and a key focus of the entire GC.

Membership numbers at the club have continued to grow in all categories. Each new member has been interviewed by a GC member by way of welcome to the club.

There was an increase in membership numbers of 6.5% in December 2022 compared with December 2021.

- Total member numbers as of 30 Dec 2022 were 1625 compared with 1526 as of 30 Dec 2021, an increase of 99 members. This is continuing to grow in the first two months of 2023, with 1677 members by the end of February 2023.
- The percentage across membership categories compared to last year are similar, though it is recognized that the percentage of members eligible to vote in elections is gradually decreasing over time.
- It is clear we need to continue to promote crew membership to those on sail passes and that the benefits of membership need to be better promoted.
- The General Committee recognizes that member retention is as important as acquiring new members. Reasons for member resignation will be captured going forward.
- 73% of current members are Male and 27% Female compared with 74% male and 26% female at the same time last year.
- Approximately 25% of our members are under 45 years, which is the same as last year.

New Carpet

- Quotes received from two contractors – further detail is required to enable the contract to be awarded and for planning purposes (given the need to move boats during the dredging)
- Water Technology is undertaking soil samples and analysis as a pre-requisite to extending our dredging permit to enable dredging inside the marina

- Noting lead times from planning and permits, a working group has been set up (Neil Sargeant, Nick Barber, John Mooney, Peter Strain). Will consider options and obtain quotes.

Comparison of options for attenuator replacement (wavescreen vs breakwater extension).

- Quotation has been received but will wait until seabed lease is further progressed before investing in this work.
- Wave study has been completed

Race Management and rescue boats Asset Management Planning has been undertaken.

- Priority is Redeemer Replacement
- Investigating “lease vs buy” for rhibs

Marina Maintenance

- more collars installed
- Attenuator has survived strong northerlies with no damage

Seabed Lease

- Parks Victoria has re-engaged and has indicated a new plan from the Surveyor General will be available by the end of March, which will enable Lease negotiations to progress.

Aquatic Report HY 2023

On behalf of the aquatic category and subcommittee I am pleased to submit this report on our recent activities.

The subcommittee has grown in number from five to eight, consisting of Stephanie Desira, Rupert Hugh Jones, Kerry Watson, Tony Ryan, Ralph O'Shaughnessy, Andrew Mulholland, Christina Wilhelm with Greg Wallace as Chair.

We would like to acknowledge the work of the previous Chairman Jack Hawkins and thank him for his contribution.

The committee meets regularly to discuss and address issues raised by members of the category.

Current topics on the agenda are; Changeroom conditions, club maintenance, water safety and swimming protocols, events – e.g. winter pier to pub, apparel – swimming caps, bathers and tops, Social Activities, interaction with RBYC GM. The committee maintains regular contact with the GM and Commodore.

As noted previously the category is experiencing a continual influx in members.

As of Feb '23 133 Members, and Feb 22 111, representing a numeric net growth of 22.

It should be noted there are numerous active swimming members who are within other categories of the club. Currently 225 RBYC members receive the fortnightly Iceberger Newsletter.

Cleaner Sailing Sub-Committee

Report to the 2023 Half Yearly General Meeting of the RBYC

An extract from the Terms of Reference for the CSC includes:

“The purpose of the Cleaner Sailing Sub-Committee is to provide a platform for initiatives, information, advice and views to the General Committee on matters relating to the environment and sustainable practices within the Club.

The role of the Cleaner Sailing Sub-Committee is to assist the GC to identify and promote projects, operations, and activities within the Club to improve the environmental capital, and long-term environmental well-being of the RBYC community.”

In FY23 the CSC has focused attention in the following projects:

1. The Clean Marina Australia Program.

This is part of an international movement to improve marina ecological management. The International Council of Marine Industry Associations (ICOMIA) was created in 2005 to help coordinate this movement. In Australia the Clean Marina Program is run by the Marina Industries Association.

With CSC assistance, the General Committee has now endorsed the program and through the Sailing Office is pursuing Level 3 accreditation under the scheme. Currently there is difficulty in achieving compliance with water runoff and containment from the hard stand. Negotiations are continuing.

2. Sailors for the Sea

This international organisation runs a program of regatta accreditation focusing on environmentally responsible operations. It includes such measures as minimalisation of paper by using digital NOR and SIs and avoiding single use of water bottles and other disposable items. The Club has already instituted some of the required changes. Such measures are important to all and especially to the new generation of sailors. Sail Melbourne incorporated many of these practices as the Club moves toward formal accreditation.

3. Life Jacket Recycling

RBYC has joined with the LifeBag organisation to recycle out of date life jackets to become a series of products including durable hand and shoulder bags. Proceeds of the scheme are to be donated to a number of organisations including the Volunteer Coast Guard Service. A yellow bin for donations is located in the lower car park. There has been an excellent response from both members and the LifeBag organisation.

4. Marina Flotsam Program

The prototype flotsam bin and scoop has been in place throughout the current season. The original scoop disappeared and has been replaced by the CSC Mark 2 scoop.

The program has been compromised by members using the bin as a general rubbish bin in spite of the attached signage. The success and development of the initiative will depend on the co-operation of members. Helpful feedback has been received formally from David Bingham along with a number of oral comments from members. If involvement from members can be achieved this pilot program could be expanded.

5. Sail Recycling

Club administration is examining the Sails to Shelter organisation as a possible solution to the reuse of old sails. Sails to Shelter repurposes sails to become shelter in distressed international communities. Doyle Sails has announced their support and partnership with Sails to Shelter. Other possibilities include www.sailcycleshop and www.sailexchange.com.au.

A suitable location for the new locker for the deposition of old sails has been identified and passed on to the Assets Committee and Club administration. The CSC believe this locker would be the key to successful sail recycling at RBYC.

6. Other projects include providing advice on the disposal of obsolete fire extinguishers, flares and EPIRBs. Lithium-ion battery recycling remains a world-wide problem.
7. Through Commodore Niesje Hees, the CSC has been approached by the ORCV Commodore Cyrus Allen and PhD Candidate Lillian Stewart of the Institute of Marine and Antarctic Studies at the University of Tasmania. The plan is to collaborate and leverage partner clubs across the bay.

CSC Committee:

CSC foundation member Kirsten Mitchell has left this committee to pursue her plans for further extensive travel adventures. The CSC thank her for her major contribution to the committee activities.
