The Committee continues to support the pillars of RBYC's strategic plan and has supported projects and initiatives across the board to benefit members and maintain assets. Membership has become more diverse and inclusive and the club welcomes people with varied sailing and powerboating background. At the same time, the club appreciates its non-sailing members who bring additional life to the club. Swimmers, gym members and social members make good use of the facilities and the wonderful waterfront location.

It is recognised that this is a challenging time for the Club, in an environment of rising costs and inflation. The club remains profitable and in a strong financial position. However it is a priority to contain the costs of the catering operation, which have escalated rapidly over the past year. This will be a major focus of the coming year, recognising that the club restaurant is a key benefit for members and attracts new members to the club, as well as supporting our community engagement.

Sailing Pathways

It has been a busy sailing season with club racing and regattas for One Design, Off the Beach Dinghies and Keelboats. The Club Captain's Sailing Committee report highlights successes in ocean racing, windward leeward, and more casual racing, as well as training programs for all ages, benefiting junior and youth sailing, as well as adults learning to sail.

It was wonderful this year to see a record number of boats at the annual Stonehaven Cup raced in Quest dinghies, which was run at the same time as the Cadet dinghy 100th anniversary. There were also youth teams participating in interclub regattas.

The Cruising Group has run several successful events on and off the water. Once again, Sail Melbourne was a great success as well as the popular BLiSS regatta for female skippers. Members continue to support the "Sailing Lifts your Spirits" program, a wonderful initiative that is enjoyed by skippers and crews as much as their guests, the healthcare workers who look after us.

A challenge is to improve keelboat racing numbers, noting there are several boats moored at the club who do not participate. It would be terrific to see their owners out on the water and making greater use of their boats and their club. It is recognised that people's priorities change, and we will continue to listen to our members to ensure the programs and events we have in place are what they are looking for.

Through the monthly Club Captains and Commodores meetings chaired by Australian Sailing we share experiences and build opportunities for joint initiatives. It is in all our interests to pool our resources to promote the joys of sailing in an environment of competing leisure activities. This year we hosted the Australian Sailing Summit and have partnered with the Ocean Racing Yacht Club of Victoria (ORCV) and other clubs for several events.

Membership

We aim to convert sailing members to active skippers and crew as well as increasing our overall membership numbers.

As membership numbers grow, it is even more important that members are encouraged to develop and maintain connections with the club. This year's annual presentation night was in the form of an inclusive cocktail party, with new members being encouraged to attend. Several special interest groups within the club have terrific camaraderie and are welcoming of new members, including the Icebergers, Laser Squadron and other one design fleets.

The Social subcommittee has run regular events that appeal to all members, and the Friday night draw remains popular. The club's 150th anniversary in 2025 will provide a great opportunity for club members to celebrate.

Marina, Beach and Hardstand

A priority for next winter is dredging inside the marina. As referenced in the Assets subcommittee report, we now have a permit and have sent an invitation to tender to dredging contractors.



CLUB CAPTAIN'S REPORT

Renewal of our seabed lease has since stalled due to limited resources and staff turnover at Parks Victoria. The new lease must be resolved well before any major infrastructure work progresses, including the eventual replacement of the wave attenuator.

An important ongoing consideration is our responsibility with respect to sustainable sailing. The Cleaner Sailing subcommittee has reported on initiatives under its remit.

I'd like to thank the members of the Assets subcommittee and the Marina and Attenuator advisory group for their expert advice on all matters associated with the marina and hardstand. It is essential that current and future committees continue to put funds aside for the eventual need to replace the attenuator, whether that be with a breakwater extension or other type of wave barrier, as well as the potential expansion or redesign of the marina.

Maintaining excellent and mutually beneficial relationships with government bodies and community organisations is essential to retaining our position as a premier yacht club in an enviable location. We remain aware of our role within the broader harbour precinct, and the importance of having a seat at the table in discussions with other clubs and authorities.

Clubhouse

The redevelopment of the Forecourt is underway, and due to be completed in time for the opening of the sailing season, Members are thanked for their patience in coping with the inconvenience over this period.

A new admiralty flagpole has recently been installed on the beachside of the club, and improved lighting has been installed at the street side of the building. We continue to prioritize ongoing building improvement and maintenance works.

Catering and Functions

Over the year, the revenue for the Club restaurant has been healthy but costs have risen to an unacceptable level, so that

the catering business overall has made a significant loss. This needs to be turned around as a high priority. The quality of the food offering has improved, and it is essential that we retain the friendly culture while finding ways to achieve profitability, improving cost control as well as marketing. The Club restaurant is a popular link to the community as well as a benefit to members. It is in all our interests to ensure the Catering operation is viable ongoing.

Community

We continue to support community events and recognise that it is important to be inclusive and welcoming. We have attracted a greater number of local residents as members as well as supporting local initiatives, such as the Great Bay Bayside Swim, the Rotary Recycle Regatta and the fundraising swim for Motor Neuron Disease.

Shared Values

Throughout the year we have had the opportunity to reinforce the principles of mutual respect. All members were again reminded of the members' Code of Conduct as part of their membership renewals. We use the newsletter and other forums to foster a welcoming and inclusive culture, which is of benefit to all of us.

This is my final year as Commodore, and I would like to thank the General Committee and sub-committees as well as the General Manager and staff for their considerable support over the past two years. As a long-term club member and committed sailor, I will be supporting the new Committee and the club in any way I can. It will be busy year ahead, with major sailing regattas, including the Etchells World Championship, as well as the 150th anniversary celebrations — an exciting time ahead for all club members.

Training and Racing

Upcoming Season

The upcoming 2024/2025 season holds an exciting array of regattas to be hosted by RBYC.

Several classes will have their State Championships here, Sail Melbourne will occur in late November, and a huge event, the Etchells World Championship is happening in January 2025.

RBYC will mark the 150th anniversary of the club with a regatta on March 29 & 30, 2025. We very much look forward to this occasion.

Sailing at RBYC also includes boats that sail without competing in organised racing, sailing within Port Phillip Bay or as far afield as Far North Queensland. This may occur on an individual basis, or in a group such as a 'Cruise in Company'.

The Cruising Group organises monthly dinners with speakers, to which all club members and guests are welcome. There are also sailing opportunities with 'Sailing Lifts Your Spirits', which provides an opportunity for health care workers to go sailing on members' keelboats on a Thursday evening in summer. Juniors Big Boat Day enables young dinghy sailors to have exposure to keelboat sailing.

Regattas and regular sailing place huge demands on both the Sailing Office and Volunteers. Many members of RBYC contribute their time and their expertise. This may be as a Race Officer, a Rhib driver, a mark layer, a Start Boat personnel, or someone who helps in the Office or carrying boats across the sand to the water. It is most rewarding to be part of such a team, who are deserving of our grateful acknowledgement and thanks.

Working Group

A huge thank you to the dedicated and highly-skilled members who make up the Thursday Working Group. Their contribution to the maintenance and improvement of so many of the Club's facilities is enormous. Regular jobs include maintenance of all boats associated with racing and training, and keeping the race tower operational.

ASSETS REPORT

The past twelve months has seen several asset improvement projects and purchases as well as maintenance activities across all areas of the club.

Clubhouse

Following a tender process and recommendation by the Forecourt redevelopment working group, approval was granted by General Committee to engage Long Contracting to redevelop the club forecourt, with a view to improving accessibility for members and modernising the front face of the club. This was approved by a Special General Meeting of Members in February 2024. Building commenced in May 2024 and is scheduled to be completed in September 2024. During this time the front entrance is closed, but the club remains fully operational.

The flagpole at the front of the club was removed for inspection and because removal was required for the forecourt redevelopment. An assessment was made that a replacement flagpole was required, and a new admiralty flagpole was chosen. The optimum location was deemed to be on the beach side of the club, with the smaller beachside flagpole moved to the front of the club.

Lighting on the side of the club has been upgraded.

Maintenance activities around the club included cleaning of Solar Panels on the roof, spraying of weeds and lighting upgrades (LCD) in the Members Bar & Bayview Rooms.

Carpark drainage works were completed.

Upgrades and maintenance to the steam room, sauna and men's showers have taken place. A project for next year is to improve capacity for the women's showers, improve the gym, and renew the area behind the gym, with a view to undertaking this after the Forecourt development has been completed.

Race Management Boats

In line with the Asset Management plan to ensure turnover of the Race Management Fleet of boats, the course laying boat Redeemer was replaced with an 8.3m Cougar Cat. The outboards for the entire fleet were replaced under an agreement with Leisure Sport Marine, which involved the purchase of 11 new engines with a service contract for three years and a guaranteed buy-back of 12 engines in three years' time.

Marina, Hardstand and Yard

CCTV cameras have been installed on the hardstand and marina. This is a scalable solution using the same central system as what is installed in the clubhouse, so that more cameras can easily be installed. There are plans to install cameras in the carpark once the forecourt redevelopment is complete.

All fixed marks have been cleaned and had their chain replaced. Material has been purchased to replace Harry T walkway & 2.4mR walkway in marina. Maintenance of the attenuator is scheduled on an ongoing basis.

A specialist electrician has been engaged to test the Marina for electrolysis activity.

Options for upgraded hardstand toilets are being investigated.

Risk Management and Compliance

The Club's Risk Register and Incident Management process are important tools to ensuring risks are managed and refreshed on an ongoing basis.

Marina and Attenuator Advisory Panel

RBYC's Marina and Attenuator Advisory Panel chaired by Immediate past Vice Commodore John Mooney is charged with developing a long-term plan for the marina and attenuator in acknowledgement of the limited lifespan of the

current assets.

Dredging of the Marina

Environmental surveys have been completed as required to obtain the permit for dredging of the marina. The MACA (permit) application has now been issued by DEECA. A tender document has been prepared by Water Technology and sent to Dredging contractors with a view to commencing dredging in May of 2025. Options for addressing the hole in the breakwater are also being investigated, while recognising that the breakwater is a Parks Victoria Asset.

Marina Lease

The Marina Lease expired in April 2023, and the club continues to pay monthly lease payments. This is a similar situation to that experienced at various times by other clubs around Port Phillip. Meetings were held with Parks Victoria with an agreed plan to progress. A lease boundary survey was undertaken by an approved marine surveyor and provided to Parks Victoria. The process was then stalled for several months, as our key contact had left Parks, and a new contact was not immediately assigned. We will be following up on next steps once the new team has been identified and becomes familiar with our history and current situation.

MEMBERSHIP REPORT

CRUISING GROUP REPORT

Membership is an important focus of the General Committee and a core pillar of our Strategy, ensuring members of all ages and interests value their membership, and members feel comfortable as part of the RBYC community and proud to be part of it.

Membership numbers at the club have held steady in all categories, with a slight increase in total membership during the year. While there was an unprecedented increase in total membership during 2022/23, this year has seen a more modest increase, similar to previous years.

Total member numbers as at 30 June 2024 are 1756 compared with 1726 as at 30 June 2023.

It is recognized that member retention is as important as acquiring new members. Over the 23/34 year there were 257 members who resigned and 287 new members. This compares with 185 members who resigned and 325 new members in 22/23, 225 resigned and 256 new members in 21/22, 206 resigned and 315 new in 20/21, and 213 resigned with 181 new in 19/20.

73% of current members are Male and 27% Female which are the same percentages as last year.

Of the new members this year, approximately 50% are sailing members and 50% a combination of gym, aquatic and social members. 38 new members are previous members who resigned in the past and have re-joined the club.

The total number of members eligible to vote in elections has increased slightly, although the percentage has gradually decreased over time.

Participation in the Cruising Group's off-water activities continued the trend of the first half of the year, which has been good to see. The Group continued to see less interest in monthly on-water cruises, and the decision has been to scale these back, with the Bass Straight Cruise, Annual Birthday Cruise and Frostbite Cruise now the main calendared on-water events.

The Cruising Group committee's makeup has changed in the last 12 months, with Geoff Brewster stepping down as Chairperson. A decision has been made to rotate the Chairperson role among current committee members. Sue Drummond, Rod Cuthbert and Barbara Burns have also stepped down from the Committee. The Cruising Group Committee currently comprises Secretary Terry Frankham, Rob Hurrell, Peter Strain, Peter Gebhardt and Jo Walker.

Peter Gebhardt was Chairperson for February 2024 and March 2024, and Rob Hurrell has taken over as Chairperson from March through September 2024.

The Committee continues to meet in person at the club monthly, with phone calls, emails, and, increasingly, the social media platform "WhatsApp" employed to maintain communications between meetings.

Meetings were scaled back bi-monthly during winter, or 'cruising north season'.

Cruising Group Newsletter

The decision was made to incorporate the Cruising News into the weekly RBYC newsletter.

With this change, the Committee decided to cease the Cruising Group annual membership fee, and participation in the Group will be free.

Monthly Forum Dinners

The monthly Guest Speaker Dinner is an integral part of the Cruising Group, and the recent uptake in attendees has been encouraging. We thank all speakers for making these monthly events possible and rewarding to all members. The Forum dinners that were held included the following.

In November, Rod Cuthbert presented an entertaining account of six months cruising southern Tasmania aboard his boat Halcyon. It was well attended, with approx 50 participants.

In May of this year, several of our regular cruisers departed Brighton, setting out on extended cruises of their own. Aquacadabra (Rob and Sue Hurrell), Chakana (Robina and Brenton Smith) and Saffron (Barbara Burns and Geoff Brewster) arrived back from New Caledonia / Vanuatu in September / October. Their presentation in February 2024 was informative and entertaining. Well done to the three boats on completing this great adventure.

In March, Past Commodore Peter Strain and his son Richie cruised It's a Privilege out to the Great Barrier Reef, visiting 25 reefs and 15 islands, from Lady Elliot Island in the south to just beyond Townsville and Magnetic Island in the north.

In May, Allan Haddow presented Six Months Sailing Around Tasmania – Solo. Allan's solo circumnavigation on a Compass 29' yacht of Tasmania started at Launceston in February 2020 and ended at RBYC in June 2021.

Our guest speaker for the August Guest Speaker Dinner was Cheyne O'Brien from the Bureau of Meteorology. Cheyne is a marine specialist with the bureau, with a background in operational marine forecasting, and presented on forecasting and the science behind it, emphasising the Port Phillip region and the factors that influence the weather in the local area.



AQUATIC/ICEBERGER REPORT

Annual Events

The Annual Progressive Dinner was conducted in October and was a great success, with approximately 40 attendees and 12 hosting boats turning out to enjoy a great evening in mild weather. Thanks to Pam Merritt for taking the lead in organising.

The Annual Christmas Hardstand Party was held on 9th December. Due to inclement weather, the event was hosted in the Jock Sturrock Centre, with approximately 20 people attending.

The 31st Annual Birthday Cruise to RYCV was a road trip due to a very high wind warning. One or two boats did venture across. It was a terrific turnout, and all who attended enjoyed the hospitality of the RYCV. Thanks to Jenny Collins for organising the cake.

The Annual Cruise of Bass Strait has just concluded in the last week of February and the first week of March 2024. Three boats headed to King Island, Three Hummock Island and Stanley. The boats that ventured out were Kirra Kirra, Chakana and Aquacadabra. Why Knot headed to Paynesville for the Wooden Boat Festival via Wilsons Prom.

The Frost Bite Cruise was held on the weekend of June 29th and 30th. It was a well-attended event, with up to seven yachts making the trip to Melbourne City Marina. Sundowners were held on It's a Privilege, followed by a BBQ on Sunday.

What is key is the attendance of Cath Hurley who has been an invaluable conduit between the Iceberger and the RBYC (Royal Brighton Yacht Club) – so thanks Cath.

I personally would like to acknowledge the work of the previous Chairperson Greg Wallace and thank him for his contribution and to the current committee – they have set us up for success.

From a process perspective, the committee meets monthly to discuss and address issues raised by members and as a feedback mechanism it works extremely well.

Everyone is aware of the make-up of the committee, and they feel comfortable raising items with the committee as they know they will be treated appropriately and professionally.

Current topics include but are not limited to:

- Changeroom conditions: ensuring the best facilities for all involved
- Water safety and swimming protocols, events (awinter safety briefing as a key part of what we provide to the club)
- · Regular communication about items of interest
- Ordering and making sure we have sufficient apparel such as swimming caps, bathers.
- Social Activities- such as Friday night swims and drinks night.

On the topic of Social Activities, we had 2 great swims involving lots of members of the club.

- Mid-Winter Swim Festival & Cake Bake Off (Thanks
 to Keith Badger just incredible participation and
 lceberger involvement swim was great but some of
 the cakes in the "bake off" would make any French
 chef proud.
- Winter Solstice (Thanks to Sam Paynter) over 80 swimmers participated, and we all then had a wonderful dinner and dancing in the restaurant.

Some key initiatives have been -

- Iceberger App this was a great suggestion by members and in partnership with Colin Burgess and Paul Pascoe we produced a wonderful Iceberger App which allows people to monitor their swims and provides a layer of safety in addition to the personal safety provided by the groups who swim.
- Iceberger Jackets super partnership again and seeing how proudly members are walking around in these beautifully branded in Club and Iceberger logo's makes you proud to be a member - everyone looks smart and warm (especially given our winter to date).
- Honour Board in conjunction with the club, we are updating the honours to reflect new Iceberger Members and those winners of the key swims over the last few years.

As of July, there are 138 Aquatic members, however there are another 70 other assorted by the Club - Members who also class themselves as Aquatic members within their other memberships (EG Senior, Gym, Crew Plus) - giving a total of 208 members who belong to the Aquatic group.

Thanks for allowing me to be part of this great club and tradition.

INCLUSION AND DIVERSITY ADVISORY GROUP

CLEANER SAILING REPORT

The Inclusion and Diversity Advisory Group (IDAG) is committed to ensuring new and longstanding members from diverse backgrounds feel welcome at RBYC.

In March 2024 it was 3 years since a membership survey was conducted. Last year, the General Committee accepted the IDAG's recommendation that a similar survey be conducted to enable comparison with previous data, regarding member profiles, priorities and satisfaction with the club. This was to assist in driving recommendations to sub-committees, as well as indicating how members feel about their club.

An invitation to participate in this RBYC membership survey was sent to all members over 18 years of age. In 2021 the response rate to the survey was 38% which was sufficient to provide meaningful feedback. In 2024 the response rate was 42%. While assessing inclusivity is not the sole purpose of the survey, the responses and written answers do provide valuable information about whether members of all categories feel welcomed and included in club activities. The IDAG and General Committee will use the outcomes to assist in prioritising future focus areas. The key challenge

is to foster a club atmosphere while being welcoming to a broader spectrum of the community.

The Australian Sailing Summit hosted by RBYC in June had a focus on inclusion and improving participation from diverse groups. The benefits to yacht clubs include increasing membership, meeting sport regulatory obligations and increasing public support and the volunteer base. RBYC supports the Australian Sailing Inclusion and Diversity strategy.

NAIDOC Week was held from 7 - 14 July this year and RBYC flew the Australian Aboriginal Flag and the Torres Strait Islander Flag throughout the Week. NAIDOC Week celebrates the history, culture and achievements of Aboriginal and Torres Strait Islander peoples. It was noted that the Bayside City Council website includes some terrific material about the connection of the Aboriginal people to the Bayside area.

Over the next year, the group will work with other committees and the community to initiate positive change, and in particular to attract more women and young people to the club.

Work continued during 2023/24 on improving sustainability at RBYC. This included the Club being awarded Level 3 accreditation in the Marina Industries Association Cleaner Marinas Program. RBYC is one of ten Victorian Clubs awarded the level 3 accreditation which acknowledges the Club's rigorous environmental management systems. Second, the Sail Melbourne regatta was run under the auspices of the Sailors for the Sea Clean Regattas certification. Third, the use of single use plastic bottles has been discontinued across the Club and hospitality facilities.

In late 2021, the Club installed a large solar system and up until late July, the system had generated almost 300 MWh of electricity, and saved 180,000kg of carbon emissions, which was the equivalent to planting 3510 trees. The system meets about 25% of the Club's power consumption. With almost no leeway to increase solar capacity at the club, further energy savings will only come from better management of our power use.

The Sub-Committee has recently re-formed and have commenced work on setting the Club's aspirations and goals in terms of sustainability and the Club's strategy e.g. minimising carbon emissions and protection of the marine environment consistent with Federal, State and Local government environmental requirements. Secondly the Sub-Committee will determine the boundaries of our influence in terms of what the Club can and cannot control.

There is broad agreement on four areas of action:

- Undertake an assessment of the current situation and available information of three key areas of the Club i.e. energy use, water use and management and recycling of waste including metals, batteries and food waste.
- Continue the focus on Sailors for the Sea Clean
 Regattas certification for major events held at the Club.
- Continuous improvement in the Marina Industries
 Association Cleaner Marinas Program.
- Management of waste coming off yachts and other boats in the marina to minimise the use of single use plastics and maximising recycling

Apart from myself, other members of the re-formed Sub-Committee are Jennifer Pascoe, Jan Talacko and John O'Donoghue and we look forward to reporting our progress.

Honorary Treasurer's Report for the year ended 30th June 2024

It is with pleasure that I provide the annual financial report to members for the period ending 30th June 2024.

The club posted an operating surplus of \$522k compared with \$732k last financial year. The overall deficit was \$306k compared with a deficit of \$296k in the last financial year.

The financial narrative has been the same post covid, with increased revenue offset by rising costs. This year we saw an increase in revenue of 10%, with increases in all our main sources of income. The narrative of increased costs in a high inflation period has seen an increase in expenses of 15.6%. This came on the back of last financial year (2022/23) increasing 27.3%.

The notable increases in expenses are; cost of goods 12.7%, employee expenses 18.9% and property expenses 27.8%.


A difficult climate for operating food & beverage has seen the club make a 9% loss in the catering division. The \$298k catering loss has been the result of a very difficult year. This disappointing catering loss has reduced the overall operating surplus of the club, seeing it slip below last years result. The club has much work ahead to make sure this vital part of the club thrives to continue offering a fantastic hub for all members to engage, enjoy and be part of the club.

The club has continued to invest in equipment for sailing and members. \$647k dollars has been spent to improve our fleet of race management vessels, prepare for dredging the marina, and continue work towards an improved forecourt driveway. The new boats will service our racing fleet for many years to come.



The RBYC yearly performance graph below shows historical results since the 2017/18 financial year. Clearly it shows the increase in revenue and expenses. Of note is the return to a normal operating surplus pattern after the 3 years of covid related million dollar surplus (19/20 - 21/22 years). This years operating surplus of \$522k was \$211k less then last year, whilst \$147k greater then 17/18 which is before the restaurant was fully operational.



The income by activity provides a high-level breakdown of the profit and loss by major functions: catering, marina & hardstand, sailing, membership & administration.



Bar & Catering

The bar and catering functions of the club have seen revenue improve by 6.9% to \$3,301k. A difficult climate for operating food & beverage has seen the club make a 9% loss in this division. The \$298k loss has been the result of a very difficult year. In a year which the club had 3 head chefs, management changes, increased wages costs with the award rates up 5.5%, superannuation and payroll tax increases, combined with the cost of goods, gas etc rising.

This unacceptable loss has seen many changes in management reporting, much tighter controls on rostering, menu design and cost of sales. A stable kitchen with new head chef and team hired in February has seen the cost of sales improve from 41.5% to 37.4%. New rostering controls with predictive reporting and strong targets implemented in July 2024 should see an improvement in wage cost controls. Improved employment market conditions should see stability in the kitchen. This is offset with economic conditions showing people spending less on café & restaurants. Combined with the forecourt development, this will see an impact on revenue for the first quarter of 2024-25 financial year.

The general committee look forward to an improved financial performance from the RBYC catering division, especially when the new forecourt and driveway is opened in October.

The bar & catering is a vital service to all members, something new members have mentioned when applying to join the club. It offers a welcome ambience to the club with many members and the public enjoying the offerings. As noted in our membership survey conducted in this financial year, it is an important hub for members to engage, enjoy and be part of the club.

Marina & Hardstand, Membership and sailing

This area of the club has seen strong growth in revenue.

The marina, hardstand and boat storage revenue has improved 16.6% with all the pens returning to the club. Marina and hardstand occupancy has maintained last year's levels.

Membership is again stronger than the same time a year ago. The Club had 1756 members compared to the previous year of 1726. Full details of all the categories can be found in the membership report. The increase in members and the membership rate increase has led to the 8.3% increase in revenue.

Sailing & OTB income has increased by \$2k for the year. Regatta's and sailing training programs have driven this.

Capital Expenditure


Capital expenditure for the year totalled \$647k. Significant expenditure on sailing race management vessels, marina and the forecourt development.

Cash Flows & Financial Position

Cash and cash equivalents at end of financial year was \$1,147,352 down \$340k from last financial year. Net operating cash flows were \$688k compared with \$794k in 2023. Total borrowing by the club as at 30th of June was \$223k compared to last year \$500k.

The historical graph below showing the "Cash vs borrowings" shows the strong position the club has progressed since the completion of the new restaurant, Olympic deck and OTB yard in 2017/18. The club has paid off most of the loan (129k to go) and increased its cash position. Our fleet of race management vessels has been rejuvenated, and we have spent \$263k on the Forecourt works / dredging works so far.



Summary

The \$522k operating surplus allows the club to continue to invest in members' services. Our fleet of race management vessels is now first class and will enable the club to run high-level club racing and regattas for many years. The continual improvement in our clubhouse will make it a great place for us to call home.

Improvements in the catering section of the club will help improve future operating surpluses and is important as it provides a vital social hub for members to engage, enjoy and be part of the club.

I want to thank all members, management and staff for making the club a fantastic place to be a member, and thanks also to the Finance Committee.

Notes to the Financial Statements

For the Year Ended 30 June 2024

The financial statements cover Royal Brighton Yacht Club Inc. as an individual entity. Royal Brighton Yacht Club Inc. is a not-for-profit Association incorporated under the Associations Incorporation Reform Act 2012 ('the Act').

The functional and presentation currency of Royal Brighton Yacht Club Inc. is Australian dollars.

The financial report was authorised for issue by the General Committee on 22 August 2024.

Comparatives are consistent with prior years, unless otherwise stated.

1 Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with the Australian Accounting Standards - Simplified Disclosures and the Act.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Material accounting policy information relating to the preparation of these financial statements are presented below, and are consistent with prior reporting periods unless otherwise stated.

The Company has adopted the amendments to AASB 101 Presentation of Financial Statements which require only the disclosure of material accounting policy information rather than significant accounting policies and therefore policy information which does not satisfy one of the following requirements has been removed from these financial statements:

- Relates to change in accounting policy
- · Policy has been developed in the absence of an explicit accounting standard requirement
- Documents an accounting policy choice
- · Relates to an area of significant judgement or estimation
- · Relates to a complex transaction and is required to explain the treatment to the user.

2 Material Accounting Policy Information

(a) Revenue and other income

Revenue from contracts with customers

The core principle of AASB 15 is that revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Association expects to receive in exchange for those goods or services. Revenue is recognised by applying a five-step model as follows:

- 1. Identify the contract with the customer
- 2. Identify the performance obligations
- 3. Determine the transaction price

2 Material Accounting Policy Information

(a) Revenue and other income

Revenue from contracts with customers

- 4. Allocate the transaction price to the performance obligations
- 5. Recognise revenue as and when control of the performance obligations is transferred

Generally the timing of the payment for sale of goods and rendering of services corresponds closely to the timing of satisfaction of the performance obligations, however where there is a difference, it will result in the recognition of a receivable, contract asset or contract liability.

Sale of goods

Revenue from the sale of food and beverages is recognised at the point of sale, when the economic benefits associated with the transaction flows to the Association and can be reliably measured.

Rendering of services

Revenue from subscriptions, maintenance fees and the lease of marina, hardstand and OTB space is recognised over the period where the customer is entitled to receive benefits from the service provided by the Association. Revenue is recognised when economic benefits are expected to flow to the Association and can be reliably measured.

The Association has numerous long-term leases for Marina space, spanning periods of twelve months or less. Revenue from these leases are defined as operating leases and recognised on a straight-line basis over the agreement terms. All agreements will expire prior to the Association's current lease of the seabed.

Interest

Interest is recognised as it accrues using the effective interest method, by calculating the amortised cost of a financial asset and allocating interest over the relevant period. Interest is allocated using the effective rate, which discounts estimated future cash receipts through the expected life of the financial asset to its respective net carrying amount.

Deferred and unearned revenue

The Association receives funds in advance from its members. These are treated as liabilities of the Association until the requirements of the revenue recognition criteria have been satisfied. These deferred amounts are then released to revenue.

(b) Income Tax

The Association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(c) Inventories

Inventories are measured at the lower of cost and net realisable value. Cost of inventory is determined using the first-in-first-out basis and is net of any rebates and discounts received. Net realisable value is estimated using the most reliable evidence available at the reporting date and inventory is written down through an obsolescence provision if necessary.

(d) Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment.

Items of property, plant and equipment acquired for significantly less than fair value have been recorded at the acquisition date fair value.

Plant and equipment

Plant and equipment are measured using the cost model

Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

The Association's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

Impairment of financial assets

The Association uses the presumption that a financial asset is in default when:

 the other party is unlikely to pay its credit obligations to the Association in full, without recourse to the Association to actions such as realising security (if any is held).

Trade receivables

Impairment of trade receivables have been determined using the simplified approach in AASB 9 which uses an estimation of lifetime expected credit losses.

The amount of the impairment is recorded in a separate allowance account with the loss being recognised in finance expense. Once the receivable is determined to be uncollectable then the gross carrying amount is written off against the associated allowance.

Where the Association renegotiates the terms of trade receivables due from certain customers, the new expected cash flows are discounted at the original effective interest rate and any resulting difference to the carrying value is recognised in profit or loss.

Financial liabilities

The financial liabilities of the Association comprise trade payables, bank and other loans and lease liabilities.

(f) Leases

Lessee accounting

The non-lease components included in the lease agreement have been separated and are recognised as an expense as incurred.

Exceptions to lease accounting

The Association has elected to apply the exceptions to lease accounting for both short-term leases (i.e. leases with a term of less than or equal to 12 months) and leases of low-value assets. The Association recognises the payments associated with these leases as an expense on a straight-line basis over the lease term.

g) Going concern

The Association's activities resulted in a deficit for the year ended 30 June 2024 of \$306,335 (30 June 2023: deficit \$295,958). It has a net current working capital deficit as at 30 June 2024 of \$28,350 (30 June 2023: \$239,144 surplus). Encompassed within the total is \$617,869 income for the 2025 year received in advance. The Association also has a contracted committeent for the Forecourt redevelopment of \$749,934 at year-end (note 18), which is expected to be fully incurred in financial year 2025.

The financial statements have been prepared on the basis that the Association is a going concern which contemplates the continuity of normal business activity, realisation of assets and settlement of liabilities in the normal course of business for the following reasons:

At 30 June 2024 the Association had net assets of \$4,383,123 cash reserves of \$1,147,352 and generated net cash inflows from operating activities of \$687,518.

The General Committee believe that the Association will continue to successfully manage the operations of the entity and accordingly, they have prepared the financial report on a going concern basis. At this time the General Committee are of the opinion that no asset is likely to be realised for an amount less the amount at which is recorded in the financial statements for the year ended 30 June 2024.

(h) Adoption of new and revised accounting standards

The Association has adopted all standards which became effective for the first time at 30 June 2024, the adoption of these standards has not caused any material adjustments to the reported financial position, performance or cash flow of the Association.

3 Critical Accounting Estimates and Judgments

The General Committee make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

Key estimates - impairment of property, plant and equipment

The Association assesses impairment at the end of each reporting period by evaluating conditions specific to the Association that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.

Key estimates - estimation of useful lives of assets

The Association determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

The facilities were varied in November 2019, with the two facilities consolidated into one facility for a total amount of \$1,450,000.
