6. Commodore's Report.

Commodore Niesje took her report as read, while highlighting the following points.

The forecourt redevelopment will soon be completed, which will be a valuable improvement to the club. The Committee room is complete and is much lighter and brighter.

The priority now is the dredging of the marina. The dredging inside the Marina is the responsibility of the club and should be undertaken every 10 years. Dredging was last conducted in 2010 (the dredging of the channel was conducted in late 2021). To progress with the required marina dredging the necessary preliminary steps have been undertaken, taking advice from the Marina & Attenuator Advisory Group along the way.

Between March and June 2023, the club engaged consultants to conduct extensive soil testing. To complete the process of applying for a MACA permit, an environmental survey was also required. The MACA permit for the dredging inside the marina was finally granted in May 2024. Tender documents were prepared while waiting for this approval and in June 2024 these documents were sent to nine dredging contractors. The club are now close to finalizing the preferred contractor and will commence contract negotiations in time for dredging to commence next winter. This will be a major undertaking, estimated to take the entire window allowed by the permit, from May through September.

Niesje mentioned how much she has enjoyed participating in the sailing program herself, as well as seeing all the off the beach activity over the past year. She is very much looking forward to the upcoming regattas as well as club sailing.

While the club remains profitable and is in a strong financial position, it is a high priority to contain the costs of the catering operation, which have escalated rapidly over the past year. This will be a major focus of the new committee, recognising that the club restaurant is a key benefit for members and attracts new members to the club, as well as supporting our community engagement.

Niesje thanked members of the various subcommittees for their commitment to the club. She mentioned that she has very much enjoyed getting to know the various groups within the club. She also mentioned how much she has appreciated the opportunity to meet regularly with the Commodores of other clubs as well as Australian Sailing – who all have the common goal of promotion of sailing.

Niesje thanked the staff under General Manager Phil Hall, Boating Manager Colin Burgess and Catering Manager Caroline Hollingsworth and all the office staff, noting that the past two years have given her an appreciation of the tremendous breadth of their roles.

Lastly, Niesje thanked the General Committee who have been tremendously supportive and expressed that the club will be in good hands under the new Commodore Peter Demura.
